1.0 GENERAL

- 1. The Exhibitor agrees to abide by all rules & regulations adopted by Renbel Travel Srl, Organizing Secretariat of the congress prior to, during or after the Event. The decision of Renbel Travel Srl on any question of interpretation of these rules and regulations shall be final, conclusive and binding on all parties
- 2. Space rental fees are due and payable in full under the terms and conditions and by the date indicated on the Exhibit space contract unless otherwise specified.
- (a) In the event the Exhibitor fails to make payment as aforesaid or fails to comply in any respect with the Exhibitor Rules and Regulations, participation at the Congress shall cease and terminate. Any payment made by the Exhibitor on account hereof will be retained by the Renbel Travel Srl Organizers as liquidated damages for breach of the contract. Renbel Travel Srl Organizers may thereupon re-rent said space.
- (b) In the event that the Exhibitor's cheque is returned by a bank due to insufficient funds, a 100.00 euros administration fee will be charged to the Exhibitor.
- 3. Renbel Travel Srl Organizers reserve the right in individual cases to waive compliance with any particular rule or regulation at any time.
- 4. The Exhibitor is encouraged to link their social media to the social media of the congress.
- 5. The Exhibitor agrees to obey any non-smoking regulation in effect at the facility and agrees to ensure that its officers, agents, employees, and those for whom in law that are responsible for, obey any such, regulation.
- 6. Space contracts are valid for the current congress only. A standard booth space is 3 mt. x 2 mt.
- 7. The Exhibitor will be responsible for and make good any damage that may be caused to Gran Guardia Palace.

2.0 MOVE IN AND OUT/STAFF ENTRY

- 1. Move in begins on the 10th of September prior to the events's opening. Access to the Gran Guardia Palace for set up is from 14:00 AM – 20:00 PM. Access for vehicles is not permitted, but special temporary authorization may be required to the organizer.
- 2. Move out is on 14th of September after the event's conclusion. No Exhibitor shall tear down till show is closed at 06:30 pm on Saturday. It is highly recommended that Exhibitors who are unable to move out Saturday remove smaller items (i.e. VCRs, TVs, computers, etc.) from their displays. Renbel Travel Srl Organizers does not assume responsibility for any losses.
- 3. Staff will be permitted to enter the Gran Guardia Palace thirty minutes prior to opening times. Badges must be shown for entry.

3.0 SPACE /DISPLAY

- 1. The Exhibitor agrees to occupy the contracted space during the full term of the Congress.
- 2. The Exhibitor agrees not to sublet the contracted space without written permission from the Renbel Travel Srl Organizers. This permission may be arbitrarily withheld.
- 4. Renbel Travel Srl Organizers reserve the right to cancel the contract with any Exhibitor who is in violation of any of the show rules or for misrepresentation. This decision shall be at the sole discretion of the Renbel Travel Srl Organizers.
- 5. No articles which are offensive by reason of their odor, sound or appearance or which are dangerous by reason of their combustible or explosive character will be accepted or admitted.
- 6. Display materials and signs must not overhang the aisles or encroach upon adjacent exhibits.

4.0 FIRE, SAFETY AND SECURITY

- 1. No materials which are dangerous by reason of their combustible or explosive nature will be accepted or admitted.
- 2. Exhibitors will take necessary precautions to protect and guard any products or demonstrations of products that are liable to cause accidents, injury or damage to any individual or to the property of the Gran Guardia Palace or any event suppliers.
- 3. Any Exhibitor wishing to heat food products or any other material must have written approval from the Renbel Travel Organizers. All public health and fire inspection regulations apply. Any Exhibitor wishing to heat food products or any other material must have an approved inspection fire extinguisher in the exhibit space.
- 4. Renbel Travel Srl will not be liable for any loss to an exhibit or due to the negligence of other Exhibitors or officials.
- 5. The exhibit areas will be locked during non-Show hours. Please use your own judgment in guarding against theft. Renbel Travel Srl do not assume responsibility for any losses.

4.0 CANCELLATION

- 1. Notice of cancellation must be in writing and must be received at least ninety (90) business days prior to the opening date of the event. Cancellation, for any reason within 90 business days of the opening day will result in forfeiture of all monies paid. Cancellation, for any reason, prior to 90 business days from the opening day will result in an administrative fee of 500 euros per booth being withheld from refund of any monies paid so as to cover administrative costs incurred by the organizers. This also includes contracts signed after the cancellation deadline.
- 2. Unless otherwise specified, space rental fees are due and payable in full under the terms and conditions of the Exhibitor Contract. In event that the Exhibitor fails to make payment of the contract agreement, Renbel Travel Srl Organizers reserve the right to cancel the exhibit contract without notice and all rights of the Exhibitor hereunder shall cease and terminate. Any payment made on account will be retained as liquidated damages for breach of contract Renbel Travel Srl Organizers may re-rent the said space. Failure to appear at the event does not release the Exhibitor from responsibility for payment of the full cost of the space rented.

- 4. In the event that the facility in which the show is to be held is destroyed or becomes unavailable for occupancy for reasons beyond the control of Renbel Travel Srl Organizers, or for any reason the Renbel Travel Srl Organizers are unable to permit the Exhibitor to occupy the facility or space, or if the show is cancelled or curtailed, the Renbel Travel Srl Organizers and sponsors will not be responsible for any loss of business, loss of profits, damage or expense that the Exhibitor may suffer. The reasons listed include but are not limited to fire, explosion, flood, weather, acts of public enemies, riots or civil disturbances, strike, lockout or boycott.

5.0 EXHIBITOR CONDUCT

- 1. The Exhibitor agrees that there will be no representation of any other companies and / or products other than that of the registered Exhibitor.
- 3. Two Exhibitor badges will be provided. Exhibitors wishing to purchase additional badges for staff may do so.
- 4. Exhibitors must keep their display clean and neat at all times. Cleaning should be done prior to opening or after closing.
- 5. Out of respect and courtesy for all, all business must be conducted within your allotted exhibit space. No selling may be conducted in the aisles.
- 6. The use of public address systems or other similar devices for the purpose of attracting attention to the Exhibitor's exhibit space is prohibited. The decision of what constitutes undue noise, unseemly or unethical methods shall be the right of the Renbel Travel srl Organizers.
- 7. No animals are allowed.

6.0 INDEMNITY

- 1. The Exhibitor accepts all risks associated with the use of the exhibit space. The Exhibitor shall not make any claim or demand or take legal action, whatsoever, against Renbel Travel Srl Organizers, the show sponsors or the facility in which the show is held, for any loss, damage or injury howsoever cause, to the Exhibitor, its officers, employees, agents or their property.
- 2. The Exhibitor shall indemnify Renbel Travel Srl Organizers from and against all claims and demands, costs and charges of every kind resulting from their occupancy of the exhibit space or area, for personal injuries, death, property damages or any other damage sustained by the Exhibitor or its officers, employees or those for whom in law are responsible, or a visitor to the show.
